At First City Visitation, children are our first priority. We understand that there are situations in which it may be difficult for parents to communicate regarding issues of visitation in a way that does not cause emotional harm to their child.

Because of this, First City Visitation Services is here to bridge that gap by providing a neutral site where children and parents can be assured that a supervised visit or exchange will be safe, conflict free, and provide time for the non-custodial parent to maintain or establish a positive relationship with their child.

Services

First City Visitation Services offers a neutral, child-friendly space, allowing for the avoidance of conflict between custodial and non-custodial parents or guardians for:

- Supervised exchanges
- Supervised visitation
- Parent education using "Parents Forever"
- Observational visitation notes
- Educational Supervision using the "Nurturing Parenting" Curriculum

Who is Eligible to use First City Visitation Services?



Any child, parent or guardian who meets any of the following criteria:

- Fear of possible violence or intimidation connected with an exchange/visitation
- Concern the non-custodial parent will not return the child after the visit
- Children who are in foster care because of abuse or neglect, but are allowed supervised visits
- Supervised visits ordered by the court

Cost

First City Visitation Services are provided on a Sliding Fee Scale in order to keep it affordable for everyone requiring these services. Fees must be paid in advance before a visit or exchange can take place. Some counties served by First City do pay for these visits.

Scheduling an Exchange or Visit



The first step in establishing a visit or exchange is to call First City to schedule an intake. At the intake, a staff member will explain how supervised visitation works, assist in filling out necessary forms, review the Parent Handbook, and answer any questions that you may have. There is a fee for the intake.

Once all parties have completed this process and payment has been received to cover the cost of the first visit or exchange, a schedule will be decided upon based on staff availability.
